Refund Policy and Class Space Reservation

Enrollment, renewal, membership and class fees are not refundable. A student's space is not reserved in a class until payment is received or payment arrangements have been made. Class descriptions include age and prerequisite requirements, as well as any materials fees in addition to class registration fees if applicable. Acceptance and payment of class registration fees confirms acceptance of posted material fees, which must be paid prior to the first class attended. Refunds will not be issued for class registration or materials fees for any reason.

Drop off, Attendance and Pickup

All children must be walked inside by a responsible adult (parent, guardian, grandparent, other designated adult), and signed in at the front desk. Please indicate on the sign-in form if you will be dropping your child off or waiting with them. If you are dropping your child off, you must leave a cell phone number. If your child is not a BSIL student, you must indicate the adult you have designated to supervise your child in your absence. For children who are not students of BSIL, parents may only leave facilities while their children are in class, and you must return no later than 5 minutes before the scheduled end time of their class. Children who are not students of BSIL cannot be left unattended between classes. If your child who is not a BSIL student is not in class and not in the care of an adult (18 or older), your family will be fined \$250. All children must be picked up by 4:00PM unless they are a BSIL student who has a formal aftercare arrangement with BSIL. Picking up a BSIL student between 4:10pm and 4:30pm will result in a fee of \$25, and one dollar (in addition to the \$25 late fee) will be assessed per minute after 4:30pm.
